

Special Meeting of the Membership

A Special meeting of the membership of the Association is scheduled for 10:00 AM CT at the Waterwood Pavilion, on May 6, 2023. The Special meeting is to vote on reclassifying a lot in Park Forest Village from a single-family lot to unrestricted. The lot is intended to be the location of the multipurpose building. Two other amendments to the governing documents related to short-term rentals less than 90 days are also on the ballot. The explanation for the revote on the short-term rental amendments is below:


On February 20, 2017, Waterwood adopted a new amendment procedure under Section 211.004. The new amendment process reads (in pertinent part) as follows:

• "The members of the Waterwood Improvement Association, Inc. shall have the right, at any time hereafter, to amend the Protective Covenants, all on file with the County Clerk of San Jacinto County, and the General Warranty Deed filed at Vol. 141, pages 802, et seq, Deed Records of San Jacinto County, Texas, by a majority vote of the members of Waterwood Improvement Association, Inc. who vote in the election, at a Special or Annual meeting at which a quorum is had, voting in favor of such amendment to any or all of the restrictions, conditions, and protective covenants applicable to the Waterwood Subdivision, with each member who is eligible to vote being entitle to one (1) vote regardless of the number of lots owned in the Waterwood Subdivision."

Since the adoption of the new amendment process, Waterwood has proposed amendments to the Governing Document. In years 2018, 2019 and 2022 votes were cast by mail-in absentee ballots and/or by the members voting in person or by proxy at the respective Annual meetings of the members at which a quorum was present.

However, the vote taken related to short-term rentals in December 2022 did not occur at an Annual or Special meeting as required by the adopted amendment process. Due to this interpretation of the amendment process, Waterwood's attorney has advised the WIA Board to call a Special meeting of the membership to allow for a revote of the short-term rental amendment.

Ballots are expected to be mailed out by April 3, 2023. If you do not receive a ballot packet in the mail, please contact the WIA office. Please note, to be counted, the absentee ballot or proxy must be signed, dated, and received into the WIA office by no later than May 3, 2023. If you don't plan to vote by absentee or proxy, you may vote in person at the Special meeting.




Waterwood Municipal Utility District Board President

For the March meeting of the MUD district our feature report was from the District engineer Jacob Floyd. Mr. Floyd presented his CIP (Capital Improvement Plan). His plan outlined where the district should concentrate our concerns. This aligns with our needs and requirements to meet the bond proposals which at this time our bond advisor has estimated the district, with our current tax rate, to be 2.1 million to 2.3 million dollars. This amount is a good start which lays the ground work for future and larger bond amounts.

The board members elected to raise our water and sewer rates by 8%. All members of the public in attendance agreed that this is a necessity. The new rate will appear with the July billings.

The next meeting for the district will be April 19th at 3:00 in the WIA building.

The garage sale was cancelled for various reasons, and it is possible we may decide to hold it during or at the end of the summer. Stay tuned for info on this.


Pam and Dianne will continue to head up BINGO. Dianne will be out of the country at the May meeting so Pam will step in and run the final meeting of the year.



Keith's Corner: Waterwood Maintenance for May '23

Welcome to the May version of our newsletter. Before we get started, please remember that I have asked everyone to inform Lisa at wia@waterwoodwia.com whenever you see a maintenance issue around here. I have spent several hours logging down everything that has come to my attention so far on a document called the Maintenance Master List. Keep the observations coming, folks, and thank you.

UPDATES to prior newsletters

From APRIL: WILDFLOWERS

The wildflower policy is nearly run its course up here in the subdivision. I have contacted the experts to help determine when we can mow the medians after allowing them to grow during the prime wildflower season. That time will be soon, but mowing will be done only when the flowers have completed their natural cycle. People need to be patient with the mowing for three reasons:

The general growth of the grass (and flowers / weeds / etc.) is now waist high in some areas of the median. We will have to mow this back down gradually 'in stages' until we get the grass back down to a trimmed appearance.

The weather is NOT on our side at the moment. The medians are so waterlogged that many areas to be mowed will have to be skipped until they dry out. If not, we will bog the mowers down to the axles. If we keep getting regular storms, this will hamper our efforts.

The Gayfeather area near 190 is NOT being mowed this month; those flowers have a lengthier natural cycle than the types of flowers up here.

From JANUARY: TREES ENDANGERING OTHERS' PROPERTY


This year will likely be a Bad Year for dead trees. The main reason is that the weather from the last 2 years has placed most trees out here into severe stress. That 4-month drought last summer in 100+ degree heat, combined with winter freezes_before and after, really hurt. This is likely to produce a rash of pine bark beetles throughout the area. Oak trees can get a boring-type insect as well. Watch the trees around your property, both yours and your neighbors'. If your trees are sick, dying, or leaning, stay on top of the situation and take responsible action.

If your neighbor's tree(s) start to pose an apparent danger to your property, there is good news and bad news:

The Good News is that the January Newsletter already has a complete procedure for how to handle a 'neighbor tree' situation. It involves reasonable communication between you and your neighbor. If that neighbor happens to be WIA, there is a way to handle that also.

The Bad News is that it will take more time before WIA is able to develop an enforcement policy to take action, should the neighbor choose not to do so. WIA is working to write such a policy but more work is needed before the policy can be implemented. The holdups in this situation are in the effort to assure that any WIA enforcement is fully supported by the deed restrictions and compliant with Texas State real estate law. Several people including myself are involved in this effort, which is ongoing.

FUTURE EVENTS: The May 6 SPRING FLING and the accompanying Special Meeting

Next Saturday is our annual Spring Fling. We all hope that everybody has a great time that day.

At a designated time next Saturday [see elsewhere in this newsletter], alongside the Spring Fling, WIA is holding a Special Meeting to deal with a vote on the subject of short term rental properties commonly called VRBOs or Air BnB's, among other names. This is one of the more controversial subjects dealt with since I've been on the Board. I've heard much talk on both sides of this issue. Property owners have received two mailings on this vote.

As an informed property owner and not officially speaking for the Board, I'd like to say a few things about this issue:

- At no time during my term on the Board have I heard any Director deal with the issue with anything other than reasoned discussion.
- The Board has not taken a position either 'For' or 'Against' VRBOs / Air BnBs.
- The Board has not voted 'For' or 'Against' these things.
- The Board has acted only to put this subject up to the property owners for their vote.
- That will happen this Saturday, either with you voting in person or by voting your proxy from the mailouts you have received. Read the materials carefully to know your options and rights.
- Owners of Property in Waterwood, have your voices heard. Vote your heart, your conscience, your pocketbook, or whatever motivates you. This is your chance, I urge you to take it.
- How do you want the future of Waterwood to be? Influence it between now and Saturday by your vote.

GOLF REPORT: The April 22 WATERWOOD TOURNAMENT




2023 Waterwood Open

The 2023 Waterwood Open, by all accounts, was a smashing success! 





Long-Term Recovery Group Meeting Scheduled

Our Long-Term Recovery Group (LTRG) meeting has been scheduled for *May 4, 6pm, at the New Destiny Church, 13291 State Highway 150 W, Coldspring, TX 77331*

We will have a subject matter expert give a presentation and answer any questions you may have.

The purpose for this meeting is to gain a basic understanding of what a LTRG is, what it does, and why it's important to have local government support and cooperation.

Every disaster begins and ends locally. Those who are most affected are at the local level, those who need your help the most are at the local level, those who will be first on the scene are at the local level, and those who will be the last to finish recovery are at the local level.

The first people to respond during and immediately after a disaster are our local citizens and first responders. Long after the state and/or federal government has left the county, it will be up to us to continue the recovery process. This is a daunting and extremely difficult task, if not impossible, without a strong volunteer base. A LTRG brings together multiple volunteer groups, each with a different focus and capability. An organized and recognized LTRG can apply for different types of grants and other funding to help the community recover from disaster.

If you know of any groups, churches, businesses, etc., that you think would be beneficial and contribute to our success, please invite them to attend as well. Please encourage your local elected officials and businesses to attend. A LTRG is more effective when it has the support of local government and business.






